## Terminal Handling Charges

### All SAL Cargo Company Terminals

Charges will be calculated on the chargeable weight applicable to each Airwaybill (master and house) and are having minimum charges which may be increased if additional work or expense is involved.

The following charges apply to each air waybill master or house or in instances where consignments are split for entry purposes  
 Import shipments may be check weighed or volume checked in the event of any discrepancies being found

Note: Imports consignments cleared and delivered split, or received as a part shipment will have storage charges applied to each part with the appropriate minimum applied
